News from the December 9th Town Council Meeting

- By Consent Agenda, Town Council:
 - Set a Public Hearing for the upcoming January 13, 2025 Council Meeting to consider several minor amendments to the Fletcher Land Development Code.
 - Approved Resolution R-24-05 to declare and dispose of surplus Town property by an electronic auction conducted by Auctions International via their website at <u>www.Auctionsinternational.com</u> beginning 1/6/2025.
 - Approved Budget Amendment 1 for fiscal year '24/'25 to increase the professional services budget line by \$60,000 for outside engineering assistance needed for damage assessment on flooded property within the town and in Bill Moore Park.
 - Approved grant project ordinance O-24-06 for \$1,000,000,000 for the Town's FEMA Public Assistance Disaster Recovery Project for our Hurricane Helene Recovery Park Projects. It is projected about 75% of these costs will be reimbursed by the FEMA Public Assistance Program.
 - Councilmember Trevor Lance was elected as Mayor Pro-Tem for the Council.
 - Carol Avery, of Lowdermilk Church & Company, presented the annual year-end audit results for fiscal year 2023-2024. She reported acceptance by the Local Government Commission (LGC) with an unqualified opinion.
- A Public Hearing was held to approve Resolution R-24-04 to establish a 12-month moratorium for any new proposed development within officially designated floodplains subject to the regulations of the Fletcher Land Development Code Floodplain Damage Prevention Ordinance. The moratorium shall not apply to developments with prior Fletcher permits or approvals or to proposed additions to, or accessory dwellings at, existing single-family properties.
- Ben Cathey, of McGill Associates, recommended the resurfacing of three Livingston Farms roads as 2025 Powell Bill projects, North Sunberry Trail, South Sunberry Trail, and Wild Meadow Road, at an estimated cost of \$276,000. This is somewhat above our approved budget, but it is anticipated the budgeted amount will be adequate once a final bid on the projects is received.
- Town Council considered multiple applicants for the District 1 seat vacated by Sheila Franklin. Amber McKinney was unanimously appointed by Council.
- Mark Biberdorf, Town Manager, shared upcoming scheduled budget meetings: Budget Work session on January 13th at 4pm for Department Heads to share significant departmental requests; March 18th from 8:30am - 3pm for complete budget requests by Staff & Department Heads; and May 8th at 9:00am for the presentation of the 2025-2026 recommended budget to Town Council by Mr. Biberdorf.
- Mark Biberdorf discussed an easement request from Enbridge Gas North Carolina
 to install a below ground gas line on Town park property under the outer greenway
 trail near the bridge at Mills Gaps Road. The original gas line was damaged during
 Hurricane Helene. Council approved the perpetual easement request.
- Mark Biberdorf gave an update on Hurricane Helene recovery for the Town:
 - Meetings have been held with FEMA to complete funding project requests.
 - The Henderson County contractor picking up debris has now started picking up construction and demolition debris. Henderson County continues to encourage resident self-reporting of debris locations (see the article on the next page).

2024 Property Tax Payments are Due

2024 property tax payments are due by January 6th to avoid a 2% interest penalty. You may pay by check or cash in Town Hall, mail your payment to Town Hall at 300 Old Cane Creek Road in Fletcher, put your payment in our Town Hall southside parking lot drop box, or pay by debit or credit card at https://www.fletchernc.org/departments/finance/property-taxes/.

Accepting Applications for Planning Board/ZBA

The Fletcher Planning Board/Zoning Board of Adjustment has three seats with terms set to expire on February 13, 2025. As per Town policy, there will now be an application period for all seats regardless of whether existing members wish to seek reappointment.

If you reside in Fletcher Voting Districts 1, 2, or 3, and are interested in being considered for appointment to the Planning Board/ZBA, you may fill out an application and submit it to the Town Clerk no later than Wednesday, January 22, 2025 by 5:00 pm. The District 1 seat will be vacant, and current members from Districts 2 and 3 do intend to seek reappointment. Functions of the Planning Board include recommendations to the Town Council on applications related to Rezoning, Conditional Rezoning, Special Use Permits, and text amendments to the Town's Land Development Code. The Board also reviews preliminary plats for major subdivisions as well as design review for projects in the "Heart of Fletcher" Overlay. Functions of the ZBA include quasi-judicial hearings regarding applications for variances and appeals on zoning matters. The Board typically meets once per month, on the 3rd Tuesday at 6:00 PM.

Applicants would need to be able to attend the Feb. 3 Council agenda meeting in order to introduce themselves and answer any questions that Council may have. We anticipate that appointments would be made at the Feb. 10 regular Council meeting. Storm Debris & Brush Removal Continues

Their primary focus is on helping survivors who may have received an inadequate FEMA award by guiding them through the appeals process to potentially secure more funding for repairs.

<u>Update: Rebuilding in Floodplain Areas</u>

The Town of Fletcher has now completed "substantial damage assessments" of structures located within designated floodplains within the Town limits and ETJ. Our consulting engineering firm, McGill Associates, found that a total of 16 structures were damaged beyond 50% of their fair market value. These structures will be required to be brought into compliance with the Town's current floodplain development regulations. (Structures in floodplains NOT deemed substantially damaged may be repaired or rebuilt to previous condition.)

Property owners of these substantially damaged structures have been notified by mail of this determination. If you are unsure as to whether your structure was determined to be "substantially damaged," please contact Eric Rufa, Planning Director, at 828-687-3985, to ask about your property and any requirements or permitting that might be needed in your specific situation. In many cases, there will not be any additional zoning or floodplain review, and we will likely just refer you to Henderson County for any needed building permits. But, It would be a good idea to double check with us just to make sure your structure wasn't deemed "substantially damaged".

It is also a good time to remind you that the Town is a participating community in FEMA's National Flood Insurance Program (NFIP). This enables any property owner in Fletcher, regardless of whether your property is in a designated floodplain, to be able to purchase flood insurance through the NFIP. If your insurance provider says "you cannot buy flood insurance," we would recommend you find a reputable insurance agent that can talk through your options about NFIP insurance.



FEMA Application Reminders

The deadline to apply for FEMA individual assistance due to Hurricane Helene is January 7, 2025. The quickest way to apply is on the FEMA website at https://www.disasterassistance.gov/. You can also apply in person at the Henderson County Disaster Recovery Center (DRC) located in the Blue Ridge Commons complex at 2111 Asheville Highway, Hendersonville NC 28791. They are open Monday - Friday from 8:00am - 6:00pm and on Saturdays from 9:00am - 2:00 pm. They are closed on Sunday. Fletcher homeowners and renters can visit any open DRC, not just the one in Henderson County. You can also apply by using the FEMA App or by calling the FEMA Helpline at 1-800-921-3362.
