News from the January 13th Town Council Meeting

Note: During the January 6th Town Council Agenda Meeting, Councilman Trevor Lance was sworn in as Mayor Pro-Tem and Amber McKinney was sworn in as District 1 Councilwoman.

- Mayor Preston Blakely presented Greg Walker, retired Parks & Recreation Director, the "Order of the Long Leaf Pine" award from Governor Roy Cooper's Office for Greg's dedication to Fletcher's parks and recreation program.
- By Consent Agenda, Town Council:
 - Approved Budget Amendment #2 to the fiscal year '24/'25 Budget to increase the parks maintenance line to include our cost of trail repair and playground mulch replacement due to Hurricane Helene while awaiting FEMA reimbursement.
 - Approved a Metropolitan Planning Organization (MPO) memorandum of understanding and Resolution R-25-01 for maintaining a continuing, comprehensive, and cooperative transportation planning process between the governmental agencies within the French Broad River MPO and the NC Department of Transportation.
- A Public Hearing was held to consider amendments to Fletcher Land Development Code Section 4.9(D.2), Section 5.8, and Appendix 2 which were intended to correct contradictory language in and remove obsolete cross references related to other sections previously amended. Council approved the amendments as presented.
- Police Chief Dan Terry recognized Detective Sergeant Ron Diaz for his new certification as a Crime Scene Investigator after having attended The National Forensic Academy, a 10-week crime scene investigation training program at the University of Tennessee. Sergeant Diaz shared some informational highlights on his training.
- Mayor Blakely reviewed the updated committee assignments for Council members.
- Mark Biberdorf, Town Manager, provided an update on several matters:
 - Fletcher Farmers Market On January 27th, a public listening session will be held at Fletcher Town Hall to receive feedback from potential market operators and vendors. Next steps will include the selection of a date, time, and location for the market which will probably start in May and continue through October.
 - Bill Moore Community Park repairs McGill Associates has been selected, through a request for qualifications process, as the engineering firm to coordinate the Park repair work. They have developed bid specifications for the needed repair work with the ballfield fencing and ballfield surfacing bids due by February 4th. The repair for the multi-use courts will be bid separately as well as the outer bridge repair.
 - Emergency response A County review meeting will be held January 23rd to discuss the county-wide effectiveness of hurricane emergency response efforts.
 - Town maintenance Some Leland Cypress trees along Woodhill Drive which were causing issues have been removed and the Town is still investigating low lighting issues on Rutledge Road and Tulip Tree Court.
 - Senator Budd's Office Mayor Blakeley and Mr. Biberdorf will be meeting in mid-January with a representative from Senator Ted Budd's office to share Town priorities and concerns.

Personal Property Listing Sheets Due 1/31/25

Individual Personal Property and Business Personal Property Listing sheets are due to the Henderson County Assessor by **January 31st**. If you filed an individual property listing form in 2024, you should have received a 2025 pre-printed listing form by mail. Make any changes to your property listing, due to sales or purchases, and return it to the Henderson County Assessor at 200 North Grove Street, Suite 102, Hendersonville, NC 28792. Any mailed forms must have a USPS stamped postmark no later than 1/31/25 to avoid a 10% late listing penalty.

If you acquired property that must be listed but you do not have a form, you can download a listing form from <u>https://www.hendersoncountync.gov/tax/page/forms-</u> <u>and-applications</u> or call 828-697-4870. Remember this tax listing includes personal property such as mobile homes, boats, unlicensed vehicles, etc.

Business property owners may file their listing by mail or online at <u>https://www.hendersoncountync.gov/tax/</u> page/business-personal-property.

Past Due Property Tax Payments

If your 2024 property taxes are still unpaid, 2% interest was added 1/7/25 and 0.75% will be added on 2/1/25. You may check your balance due at <u>https://www.fletchernc.org/departments/finance/property-taxes/</u> or call the Tax Office at 828-687-3985 for the correct payment amount.

FEMA Application Reminders

The deadline to apply for Hurricane Helene FEMA individual assistance is **February 6, 2025**.

The quickest way to apply is on the FEMA website at <u>https://www.disasterassistance.gov/</u>. You can also apply in person at the Henderson County Disaster Recovery Center (DRC) located in the Blue Ridge Commons complex at 2111 Asheville Highway, Hendersonville NC 28791. They are open Monday - Friday from 8:00 am - 6:00 pm and on Saturdays from 9:00 am - 2:00 pm. You can also apply by using the FEMA App or by calling the FEMA Helpline at 1-800-921-3362.

Private Property Debris Removal Program

Property owners who cannot get their hurricane debris to the right of way for the County contractor to pickup or who have inadequate debris removal insurance, may apply to have qualified disaster debris removed from their property for free through the Private Property Debris Removal Program. Storm Debris & Brush Removal Continues

- Henderson Co. estimates their contractor, SDR, has collected about 1/4 of the debris that has been set out for pick up, so they ask for your continued patience during this lengthy process.

- Residents and businesses can still place storm debris along the road right-of-way for pickup, but it must be separated by debris type and only from the storm.

From the Office of Chief Terry:

I hope the new year has started out great. I'm glad to report the calls for service regarding drug overdoses has significantly declined in the last year.



The upward trend on the use of Narcan by members of the police department has also reversed with the need to administer Narcan for opioid overdoses decreasing. We desire to see these numbers decrease even more.

As a department, we continue to proactively enforce laws related to illegal drug use and possession. Unfortunately, much of the enforcement action taken by the police department is drug related, whether it be for possessing illegal substances, trafficking/selling illegal substances, or committing theft related crimes to support a drug habit.

One way to get drugs out of the community is via the prescription pill drop box located in the lobby of the police department. This is a service for residents to safely dispose of their unused and unwanted medications and reduces drug overdoses and drug abuse by reducing the amount of medications in our community. This service is available Monday through Friday between 9:00 am and 5:00 pm.

Finally, we want to encourage anyone who may be struggling with addiction or know someone who is, to take advantage of resources and get help before it's too late. We will continue to enforce our drug laws and going to jail is no fun. But more importantly, we want everyone to be safe and healthy. Please share these resources with those who may benefit. Together we can do more.

Small Business Administration (SBA) Loans

The SBA offers three types of disaster loans at low interest rates (typically less than bank loan rates):

<u>Home Disaster Loans</u>: Loans to homeowners or renters to repair or replace disaster-damaged real estate and personal property, including automobiles.

<u>Business Physical Disaster Loans</u>: Loans to businesses to repair or replace disaster-damaged property owned by the business, including real estate, inventories, supplies, machinery and equipment. Businesses of any size are eligible. Private, non-profit organizations such as charities, churches, etc., are also eligible.

<u>Economic Injury Disaster Loans (EIDL)</u>: Working capital loans to help small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private, non-profit organizations of all sizes meet their ordinary and necessary financial obligations that cannot be met as a direct result of the disaster. These loans are intended to assist through the disaster recovery period.

Disaster Legal Services: Free Legal Clinic

Residents affected by Tropical Storm Helene can receive free legal assistance on FEMA claims, appeals and landlord/tenant issues. Volunteer attorneys from the NC Bar Association, Disaster Legal Services and Pisgah Legal Services will be available on **Saturday, February 1, 2025, from 9 a.m. to 2 p.m.** at the Henderson County Disaster Recovery Center (DRC) located in the Blue Ridge Commons complex at2111 Asheville Highway in Hendersonville, NC 28791.

Walk-ins are welcome or you can schedule a 1-hour appointment at <u>https://www.signupgenius.com/go/60B0F4BADAB28A7FC1-54283025-</u> <u>disaster#/</u>.

In order for a volunteer attorney to better provide you assistance, please bring with you the following information and documentation:

 Any and all documents related to FEMA or other legal issues, including applications, letters, prior appeals submitted, leases, contracts, etc.

– Your FEMA claim username & password to access your claim/appeal online.

 Any and all documents related to the reason for the FEMA denial, such as identification, deeds/titles, leases, etc.

Please be aware that you will be asked to sign a "Free Legal Clinic Client Assistance Agreement Form" at the start of your appointment. To review it prior to your arrival at the DRC, please click the "Legal Clinic Client Disclaimer.pdf" link at the bottom of the above noted website.
